Dear Citizens of Maine:

In 2009, I began my third term in the United States Senate. I remain deeply honored by the trust the people of Maine have placed in me, and I appreciate this opportunity to report on some highlights of my recent work in the U.S. Senate.

A significant accomplishment came in December when the President signed transportation legislation that includes a provision I authored to create a one-year pilot project to allow trucks weighing up to 100,000 pounds to use federal highways in Maine. This is moving heavy trucks off Maine's secondary roads and out of our downtowns and onto our modern, multi-lane, controlled access highways for one year, during which time a study of the impact on safety, commerce and road wear-and-tear would be conducted. In addition, this change helps to level the economic playing field, as neighboring states already have this exemption.

My appointment in early 2009 to the powerful Appropriations Committee has allowed me to have greater influence on the funding of priorities that are important to Mainers, such as shipbuilding, health care, education, and transportation, while also giving me the ability to continue pressing for the elimination of wasteful spending that exacerbates our federal deficit.

As a member of the Senate Armed Services Committee, I continue to be an advocate for Bath Iron Works, the Portsmouth Naval Shipyard, the Maine Military Authority in Limestone, and the many other defense contractors and institutions in Maine that contribute so much to our national security. In August, I traveled to Iraq and Afghanistan and had the opportunity to meet with many service men and women from Maine. My conversations with them were the most important aspect of my trip to the region. Our troops are brave, dedicated, compassionate, and highly skilled. I will continue to work hard to ensure that they have the support their difficult missions require.

Perhaps the greatest challenge facing our nation continues to be the struggling economy, and among my highest priorities are getting our people back to work and our economy back on track. That is why in early 2009 I joined a bipartisan effort to pass the American Recovery and Reinvestment Act. The bill contains robust infrastructure spending, significant funding for state aid and education, and tax relief for low- and middle-income families and for small businesses. As a result of this bill, Maine is receiving approximately \$133 million for highway investments, more than \$50 million combined for the Clean Water and Drinking Water State Revolving Funds, and \$70.5 million for weatherization and energy efficiency projects.

Energy policy remains another great challenge: America's reliance on foreign oil harms our economy, our security, and our environment. Meeting the challenge of developing energy alternatives will provide great opportunities for Maine to build an economy for the future, with new industries and thousands of good jobs. This endeavor received a significant boost last October when the U.S. Department of Energy announced an \$8 million grant for deepwater offshore wind research at the University of Maine, and Congress also approved \$5 million I sponsored for the Maine Offshore Wind Initiative at UMaine. This January, the U.S. Department of Commerce announced a \$12.4 million laboratory construction grant for the University of Maine. I strongly advocated for these projects because, with some of the strongest winds in the nation off our coast and some of the best engineers in the field, Maine has great potential as an ideal location for offshore wind projects and can take the lead in the development of clean, renewable, and affordable energy for America. Estimates are that development of five gigawatts of offshore wind in Maine – enough to power more than 1 million homes for a year – could attract \$20

billion of investment to our state and create more than 15,000 green energy jobs that would be sustained over 30 years.

Of course, this past year brought not just successes. A disappointment was the failure of Congress to produce bipartisan health care reform legislation that would contain soaring costs and provide more choices for struggling families and small businesses. I am deeply concerned about the nearly \$500 billion in Medicare cuts included in the bill.

It is fiscally irresponsible to raid Medicare – a program which already has long-term financing problems – to pay for a new entitlement program, particularly at a time when the number of Medicare beneficiaries is on the rise. The bill would saddle Maine’s hospitals with some \$800 million in Medicare cuts over the next ten years, and could push one in five hospitals, nursing homes, and home health providers into the red. Ultimately, such cuts could jeopardize access to care for millions of our nation’s seniors.

As the Ranking Member of the Senate Homeland Security Committee, I am committed to ensuring that our nation is as safe as possible and that government is better prepared to respond to disasters. The Christmas Day terrorist attempt to detonate explosives on an aircraft reminds us of the dangers we continue to confront. My homeland security priorities include further strengthening our defenses against terrorism and providing our first responders with the resources they need.

On March 19, 2009, I reached a personal milestone when I cast my 4,000th consecutive roll call vote, continuing a record of participating in every single roll call vote since I first came to the Senate in 1997. I am grateful for the opportunity to serve Maine in the United States Senate. Dear Livermore Falls residents and friends,

This past year, Mainers have faced many challenges. Yet as I travel across our state, I am inspired by the stories I hear of people coming together to help their friends, families and communities. I also continue to hear from many people who are worried about losing their jobs, heating their homes, putting food on the table and getting affordable health care. Although there are a few hopeful signs that our nation's economy is beginning to recover, there is much more we need to do to help Maine's economy.

As an example, I am very pleased that late last year the newly-created Northern Border Regional Commission received funding and will now be able to start working to create economic development and job creation projects in the most economically distressed areas of Maine, New Hampshire, Vermont and northern New York.

I am also pleased that Congress authorized a pilot program that would exempt Maine's interstate highways from the 80,000 pound federal truck weight limit and help get larger trucks off our back country roads. This is a good first step in addressing this issue, and I will continue to work to find a lasting solution that will improve road safety and increase productivity.

Our country has also taken important steps forward in protecting and improving veteran's benefits and health care. In October, I joined a number of my colleagues at the White House as President Obama signed the Veterans Health Care Budget Reform and Transparency Act. The legislation, which I helped introduce earlier this year, authorizes funding for the Department of Veterans Affairs (VA) medical care programs one year in advance of the start of each fiscal year, helping to end decades of uneven budget cycles and funding shortfalls that have contributed to the rationing of VA health care and inadequate access to treatment for our veterans.

Finally, my staff and I remain committed to providing quality constituent services whether it is help with cutting through red tape or a question about federal programs and benefits. Dear Constituent,

The Legislature recently wrapped up the second half of the 124th Legislative Session with a great deal of success despite the challenges of a major recession. The session focused primarily on strategic reductions in state spending as state revenues from sources like income and sales taxes dropped. Combined with efforts from last year, state spending was reduced by over \$800 million.

Despite early spending reductions, the legislature was able to make significant restorations back to key areas of the budget such as K-12 education funding, higher education, social services, and revenue sharing to communities.

I know reductions to revenue sharing have been a big concern to a number of municipalities. This is what municipalities receive in funding from the state, and is based on tax assessments, municipal populations, and state valuations. The funds come from the state's sales tax, personal and corporate income tax and the service provider tax. The revised state budget restores \$6 million in FY 2010 and \$5 million in FY 2011 to revenue sharing. For Senate District 17, this means our local communities will receive \$178,050.79 for FY 2010 and \$137,538.75 in FY 2011 in restored funds.

In addition to revenue sharing restorations, over \$511,000 has been restored to General Purpose Aid education funding to municipalities and RSUs in our region for FY 2011. Moreover, the approved budget also restores a number of health and human services cuts that impact social services and vulnerable populations in our communities.

Many of the spending reductions do provide state and local governments with an opportunity to rethink how we deliver many services. Through a combination of newer technologies and collaborative efforts, we can enjoy many of the same services we have in the past by becoming more innovative.

Dear Friends and Neighbors:

The Second Regular Session of the 124<sup>th</sup> Legislature began in January of 2010 and is expected to come to a close in the first weeks of April 2010. During the Second Session the Legislature deals with emergency and carry-over bills. Carry-over bills are pieces of legislation that originated in the First Regular Session but need more investigation, debate or study. I encourage you to visit the Legislature's website at [www.state.me.us/legis/](http://www.state.me.us/legis/) for up-to-date information on all of the bills before the Legislature. From here you can search for bill submissions, amendments, public laws and voting records of all legislators.

Perhaps the most difficult task that we are dealing with is the \$438 million budget shortfall. While I am glad that the Governor has pledged not to raise taxes in order to balance this budget, I still cannot support it as it contains cost shifts to the municipalities without any notable structural changes. We need to control state spending rather than relying on short-term solutions and tax shifts.

Regarding local issues, paving on Rt. 4 has been included in the Maine Department of Transportation's Maintenance Surface Treatment plan for 2010. I know that we will all be looking forward to that as we have been waiting for this project to come to fruition.

The first item that I had the pleasure of doing as the Town Manager of Livermore Falls was to write the letter for the Annual Report. My introductory statements were to bring open communication from the local government to the people. Unity of efforts between our citizens, government, and Board of Selectmen can propel the Town of Livermore Falls forward in all projects. Communication has improved this year, but the effort is not complete. I will continue to provide constant and open communication to the citizens of Livermore Falls and I hope that you will in return.

The last year would be considered a challenging year for any and all municipal managers without prejudice of experience. I have been humbled on several occasions by the enormity of some of the projects that we took on this year. It makes those projects that more special when we have succeeded. The Police Department and Fire Department were very successful in creating a plan to overcome the dissipation of our local dispatch center. To the Town Manager, Selectmen and Citizens;

In 2009 the Livermore Falls Police Department received and responded to 3827 calls for emergencies and/or assistance. In addition, 122 arrests were made, 193 criminal summonses issued, 388 traffic summons issued and 1536 traffic warnings and/or defects were issued.

With the closing of our dispatch center November 30, 2009 it has been a continuous learning curve for the police department. We are still not connected to the county dispatch record system. Our geographic location seems to be the biggest issue at this time which is creating a bottleneck of paperwork for the officers and the potential for some responses not to be logged on busy shifts. The officers have to log in, respond and complete each call for service received. We do the best we can with what we have and put the safety of our citizens as our first priority.

**LOBBY HOURS are 8AM. - 4PM. Monday – Friday** as long as the Administrative Assistant is available. In her absence I try to keep the lobby open, but I close it if I am needed elsewhere responding to calls or assisting the duty officer.  
**IF THE LOBBY IS CLOSED AND YOU NEED AN OFFICER USE THE CALL BOX ON THE WALL AT THE RAMP ENTRANCE**





This past winter was an easy one compared to the last couple of winters. We used 800 yards of sand and 425 tons of salt. The new plow trucks worked very well, especially the wheeler down in East Livermore., with twice the payload of our other trucks. Warren can stay down there plowing and not have to run back to the shop to get more material.

Bruce Manzer did our paving last summer and it came out very well. We put the surface coat on the tree streets and Moosehill Road.

Our paving request for this year is to reclaim and put coal mix on the Record Road and do some on the Strickland Loop Road. These roads require a lot of patch each year and are in very bad shape.

On a final note, please have patience with us this year. We are one man short so you will probably notice a difference in services.

## **2010 Transfer Station Report**

Starting July 1st our transfer station will be Single stream recycling. This means all recyclables will be placed in one container, no more separating at your home or at the transfer station.

This type of recycling will accept more items than we currently accept now. This includes milk & juice containers, drink boxes, wrapping paper and all plastic marked with #1 thru #7 on it including plastic grocery bags, and more.

For a complete list ask the attendant at the transfer station or stop by the Town Office and pick one up.

The Town is putting in two compactors at the transfer station - one for Recyclables and the other one for household trash. Starting July 1st when you pull into the transfer station the first compactor will be where all of your recyclables will be placed, the second compactor will be where the household trash will go. The wood, bulky metal, yard waste and brush will still be in their same areas.

Also starting July 1st all bulky demolition, televisions, computer monitors and shingles will be taken at our facility. Nothing will have to go to Jay.

Contract haulers will be hauling directly to our facility starting July 1<sup>st</sup>.

## TAX COLLECTORS REPORT

Under the July 1 through June 30 fiscal accounting period, annual reports must be prepared and printed prior to the end of the fiscal period and before the post annual audit can be started. May 1st through April 31st has been selected as the most reasonable reporting period that can be offered to the voters for comparative information purposes.

Taxes are committed to the Tax Collector at the time the annual bills are mailed out and at the expiration of eight to twelve months any unpaid balances are placed on lien and turned over to the Treasurer for collection. Any liens which are not paid in full with interest and recording fees foreclose after eighteen months and become the property of the Town. The Treasurer and the Tax Collector accept partial or installment payments in order to assist taxpayers to avoid liens and foreclosures.



## 2009 Sewer Department Report

The Main Street sewer project is designed and ready to be put out to bid. It looks like the actual construction will be during the summer of 2011. The project will go from Bridge Street in Livermore Falls to Pineau Street in Jay and will replace all water, sewer, storm drains, and travel surface. All efforts will be made to keep interruptions in traffic to a minimum.

Chapter 583, a rule to control nutrients in surface waters in Maine, has the potential to be expensive to the sewer users in Livermore Falls. This rule deals with phosphorus limits in the river. All reduction of phosphorus discharges from households will be much cheaper than chemical removal at the treatment plant. Look at labels and try to pick the low or no phosphorus brands.

Once again I will mention what manufactures call flushable products. These products will flush but they also will plug service lines, will build up in storage tanks, will plug treatment pumps, and will cause expensive problems to the treatment process. Wastewater and toilet tissue are the only things that should be put down residential drains. I estimate that over the last 5 years rags and other debris have cost the department around \$50,000 in line and tank cleaning plus costly pump repairs.

The State estimates that over the next ten years the need for sewer system upgrades in Maine is close to 1 billion dollars. The ability to fund these projects with loans, grants, and sewer use fees is inadequate at best. Just to keep up with collection system maintenance and operations, the recommendation is to raise sewer rates every 2 to 3 years. We have not done this in the past and face increasing rates just to meet expenses. Our expenses reflect the cost to treat 600,000 gallons of wastewater every day plus maintain a treatment plant, and 15 miles of collection system with 4 pump stations. Any citizen who would like to see the plant can call for a personal guided tour.

To the citizens of Livermore Falls:

The Trustees of the Livermore Falls Water District hereby submit their annual report for the year ending December 31, 2009.

This past year we did not take on any major water main replacement contracts but instead focused our attention on in house projects. The next expected replacement and/or upgrade is the 1.1 miles of water main included in the Main St. project which is projected to go out to bid in October of 2010.

In House projects:

-Bellaire Drive: 400ft. of both water and sewer main were replaced. This was accomplished jointly by the Livermore Falls Sewer Department and Water District personnel all excavations and pavement work were accomplished by Elwood Leighton.

-Hill Street Terrace: A new 2" sprinkler system for fire protection was installed at this newly remodeled apartment building located at 27 Depot street.

Operational upgrade projects:

-Radio Read System: The existing Badger generators and outside readers were replaced with a new ORION radio transmitter and software system. This new system has allowed us access to trending information at an almost constant rate which was impossible under the old program and has already proven itself to justify the cost in terms of providing valuable data back to the customer base which has greatly enhanced customer service.

-Telemetry upgrade: The existing telemetry landline signal has been replaced by a radio transmitted signal. This upgrade has eliminated the monthly fixed landline utility cost and reduced the potential threat of lightning strikes.


-Boiler upgrade: Replaced the existing oil fired wet based boiler at the office with a wall hung gas unit. This has improved the 1960's technology efficiency rating of 70% to a new system efficiency of 90%.

Community outreach programs:

- This year during National Drinking Water Week in May we were unable to retain the services of the National Children's Theater Group. We have used their talents in the past with great success to bring about an awareness as to the importance of conservation and water quality to youth throughout the communities of Jay and Livermore Falls. Unfortunately the rules are that a community that request the services of this theater group for the first time are put at the top of the list so we lost out. We will continue to support, sponsor and expand these programs as much as possible.

### Greetings:

In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Livermore Falls in the County of Androscoggin, in the State of Maine, qualified by law to vote in Town affairs, to meet at the Livermore Falls Municipal Building in said Town of Livermore Falls on Tuesday, the 8<sup>th</sup> of June 2010 at 9:00 o'clock in the forenoon, then and there to act on the following articles to wit:

**Article 1.** To choose a Moderator to preside at said meeting.

**Article 2.** To choose by secret ballot in accordance with Title 30, M.R.S.A. Section 2061 all necessary Town Officials including one Selectman/Assessor for a two year term; one Selectman/Assessor for a three year term; one Town Clerk/Treasurer for a two year term; and three MSAD #36 School Board Directors for a three year term.

Note: The polls will open at 9:00 o'clock in the forenoon and close at 8:00 o'clock in the evening.

<b>Article 3:</b> Shall the Town fix dates of October 20, 2010 and March 23, 2011 when taxes shall be due and payable and shall the Town fix a rate of 7% interest to be paid on taxes unpaid after said date?
