New Business:

Tennis / Basketball courts

Amanda went over the costs of cleaning and repairing the courts. To bring the basketball court up to where it needs to be is \$12,170.00 To bring the tennis courts up to where they need to be is \$27,020.00 These upgrades would last about 5 years.

To do these courts right it would be about \$100,000.00 each with the expectation of them lasting a very long time seeing as the courts have been there for about 50 years (+or -)

Amanda showed some different options for the tennis courts that would include a choice of making one of the courts into 4 pickle courts so that More people could be using the courts at any one time.

We already have \$24,000.00 that was voted in back in 2019 and we could use the TIF money to cover the remainder of the costs, This would leave the ARPA funds available for other needs of the town.

Vote 4-0 to approve the spending of the ARPA funds to cover the cost With what is already set aside for these vehicles.

Amanda would like to hold back on the fire truck as she is in belief that there are some grants that could help with that purchase.

In addition to have the courts redone Amanda has had requests to Repair/replace picnic tables and park benches as the ones that are there now are in bad shape, Ernie made motion with Rod making second motion 4-0 to get more information such as count the benches/tables and get estimate on the cost.
