D.E.A.T. (Dana Cummings)- Medical Marijuana Retail Store

Will made fist motion to open for discussion Bruce made second motion VOTE: 3-0 in favor to open for discussion

Dana Cummings spoke up and said essentially at this time there is no parking by the store but he would open 4 spaces at the old school and would be willing to change the front of the store so that it goes out onto Church St. and designate and paint three spots green as well as to put up signage that says 15-minute parking.

Dana has been in touch with the Maine DOT and they have replied that it would be up to the discretion of the town if the parking would be allowed.

Steve Larock, manager of The Gas Station which is next to Cumberland farms says he welcomes friendly competition as it gives the local patients more options for their relief.

Roger Moulton spoke up and says he is upset with planning board and the Selectboard board with the abundance of retail stores and wants to know what if anything is going to stop the growth of more stores.

Robert Tarrant from BJ's Cannabis asked if there was any chance of the hours of operation would be able to change as they are set up at this time to
