

### Appropriation

No additional appropriation will be necessary to complete this project. \$47,578 was carried over last year to implement a single stream sort plan. Projected tipping fee budget lines are coming in under budget. There is a real distinct possibility there will be \$35,000 left in the MSW budget. Together these amounts will more than cover the cost of this project.

### Contracts

Several service contracts will be necessary to implement the single sort facility change. All contracts will be put out to bid or three quotes retained for services. The following are contracts that we would pursue:

- Concrete Install
- Electrical installation
- Waste and Recycling Trucking
- Waste and Recycling Disposal (Eco Maine)

### **Cost Savings**

Refer to the spreadsheet provided to see a revised budget.

Comparatively, we can reduce tipping fees for recyclables and waste. Waste tipping fees are \$85/ton in Jay and \$55/ton at Eco Maine. Recyclable tipping fees are \$30/ton in Jay and \$0-15/ton at Eco Maine. The imperative cost savings would be if we can save the difference in transportation. Obviously, there is a significant distance difference between Jay and Portland. Compacting our waste and recyclables are the important aspect of this plan. Preliminary costs project transportation of containers to Portland at \$255/haul. When the math is completed, there is nearly a \$59,000 savings in the first year. This is a permanent savings plan. Savings would be recognized annually. The pay back on our investment would be less than 2 years.

#### Ease of Use

Transfer station hours would remain Tuesday, Thursday, and Saturday 8 am to 4 pm. The user friendly set up will enable people to utilize the Transfer Station quicker, requiring less hours. Private haulers would utilize the facility during those same hours.

### Other Factors

Private hauler tipping fees has been an issue lately. With the implementation of this plan, private haulers would be required to dump at the Livermore Falls Transfer Station. Control of the recycling ordinance would be enforced in Livermore Falls. We could accept private haulers at a reduced rate. If haulers can't comply with local ordinance, they would have to pay tipping fees to another entity at their will. Compliant haulers will see no effect but location.

Since compacting of waste and recyclables would take less space, a lot of storage space could be used by the town. This could be for transfer station programs not currently offer, such as bulk waste items. The space could also be utilized for materials that the Highway Department currently has trouble accumulating, such as patch.

### Town Manager's Proposal Livermore Falls Transfer Station

### Overview

Replace the existing use structure of the Transfer Station to a Single Stream sort facility. This would include the purchase of two 4 yard compactors, outfitting the compactors for installment, and organizing multiple contracts for disposal of waste and recyclables.

In the same area that we currently have two open-topped containers, for waste accumulation, we would utilize for the compactors. The compactors would be situated below the step so that easy disposal of waste and recyclables would be possible, at a comfortable height into an open-topped compactor. The first compactor, closest to the gate, would be for single sort recyclable materials. The two compactors would be slightly separated by space. The second compactor would be south of the other and would a mirror design of the first. Therefore, both compactor openings would be together for ease of use. A user would drive in, throw recyclables into the hopper, pull forward, throw waste into the hopper, take a uturn, and exit.

### Single Sort Recycling

Single sort recycling is a service offered by a couple of facilities. All recyclable waste indicated by the recycler can be thrown, and compacted, in the same container. This allows recycling to be completed easier, which increases recycling. The material is transported to a facility in which it is sorted by an automated process. The facility that processes the waste will stockpile and try to resell the material, to recoup the cost of the process.

There are a couple of facilities that do this service. This proposal is to use Eco Maine. They are a municipally owned business in Portland. They are specifically designed, due to their municipally designed make-up, to structure rates that are sympathetic to the turbulent market rates of recyclables. Eco Maine provides educational material to inform residents of the process, included with the contract.

### Waste to Energy

Eco Maine also has a waste to energy pant. They incinerate waste to make electrical energy that is then sold back to the power grid. They have very little by product that comes in the form of ash. The ash is brought to a landfill that is ultimately where our waste is going now.
