1. Called to order by Louise at 6:30 p.m.
2. Louise mm Ernest s, minutes from November 3rd accepted as read. 5-0
3. The Fema monies were received of \$52,646.82 the states share will follow.
4. William mm and Jackie s, to grant liquor license to Mark Paradis DBA Chuck Wagon Restaurant. Approved 5-0
