Animal Control Ordinance

We had a large turn out for this Ordinance and many residents spoke, here is a list of names of most residents that spoke. Kayleigh, Rebecca, Scott, Doreen, Joshua, Destiny, Robert, Kayal, Erin, Johanna Andrew, Joshua and Amy. They all have the same concerns about the Ordinance, they believe it is overreaching and listing out the number of birds you can have does not make sense as they use the birds to feed their families and for a family of four you would need at least 10 birds to feed them. Plus, we have to have a place to slaughter, and the ordinance prohibits that. Almost everyone that spoke said they take care of the animals and their yard; they feel this ordinance is for people to complain and then you are going to go do something. They also stated that this is for the town of Livermore Falls not for the people in the village and it's an overreach and stopping people from providing for their families, and they are going to vote this down. Scott said he takes his goats on hikes, graze land and brings them to home schools to teach how to take care of them. Scott did admit that he has too many goats. Other residents with goats say they keep their yard clean, they have shelter, and they use their milk for their family. Everyone also felt that we should have notified residents that the town was doing this ordinance so they could have input. Erin mentioned she has had issues with a neighbor and her birds, she said just talk to your neighbor. This ordinance came about for two reasons a dog that never stops barking and others have come to the meetings because their neighbor was not listening to their request. The planning board did the best that they could and maybe if we could have heard from everyone it would have made a difference. Residents said they go to our town website for information like when meetings are and other information, and it has not been updated in a long time. Will did say the select board meets on the 1st & 3rd Tuesday of every month at 6:30 pm and the planning board meets on the 3rd Wednesday of every month at 6:30pm. Will said he is aware of issue's the town is having with the website and it is cumbersome to use. Will asked Carrie about getting a new website, and Carrie said it is very expensive. Will mentioned about putting it in a future budget. Will also encourage the residents to get talk about their concerns tonight, Solar Ordinance – Will asked if there were any questions or concerns, there were no Kayliegh asked if it was already going to vote? She was told yes. Will closes the public meeting.

Responses: river, parking spaces because we are losing 20 parking spaces when they redo the road.

Question: Who would be good to engage that might be most vulnerable to natural hazards (such as Elderly populations, populations without internet, folks with health issues, etc.)

Responses: Health Reach, they can identify people that need this service and give them your Information. Food, Pantry, Soap & more, Library about who comes in to use the computers and Western Maine (bus service)

11. Department Head Discussion - Ab is working on creating a digital base form (PDF) to add to our website. There has been an increase in juvenile offenses & thefts, store owners are reporting these to us because of our relationship with the community and they see we are taking our jobs seriously.

staffing we have two vacancies still that need to be filled, we have tow officers in training one is exiting the training, and one will be entering the training, than they will be going on to the academy. We are upgrading downstairs with an access control system. The PD is still waiting on car #1 we have the car; we are just waiting for the inside guts to be done. Ab is working with staff with a robus training, and hoping to get to a point that we host training for other organizations, this is goal of mine and I think we can achieve it. The Town is back up to 24 hours coverage and has been for about two months. I will be on this schedule for the next six weeks and then back on the schedule that matches the Town Office hour for fourteen weeks, then back to the 24-hour schedule for about eighteen weeks. Will asked how we compare in staffing to other surrounding towns, and Ab said they are all in the same boat as us. Will said the board is grateful Ab has come on and brought us to where we are today. A resident asked how often we are out of town with aid? Ab said there is a really good balance right now, looking at it quarterly we received more aid in the first quarter, and we give more aid the second quarter.

Rick thanks the town for bringing him on and being able to bring his experience to help the town. Rick wanted the board to know he grew up on a very large farm and he was a goat farmer for many years. So he can speak to anyone here about all types of farm animals.

Tammy said Thursday they sent out about 500 letters to residents that still owe on 2024 taxes. This letter is a courtesy letter letting them know they were missed and to help not have to send out 30 day
