 - 6.1 Maine Farmland Trust Presentation

Thacher Carter from M.F.T. stated what they work to protect farmland. They are a resource to help towns with proposals for grants and there is no cost to the Town to for their service. It is a three-year program, the first year would be training to help support Agriculture, organize listening sessions with the public and to go over their vision, benefits of joining other surrounding Towns. Second and third year they would continue to be a resource to the town. Thacher said he was not looking for an immediate answer but would be in touch soon. Ernie Asked if it includes forestry and the answer was no, Ernie gave him info to look into about forestry. Will asked about the grants and what they would help the Town with, Thacher said things like farmers market, land use ordinances and tax programs to help support farming to name a few. Jim Cyr asked about the policy for land use. An example was Agrotourism Events. Bruce mentioned the strong present of the Amish and wants to know how this would affect them, Thacher said they have a working relationship with the Amish in town and would reach out to them to join us for the meetings and it would be up to them if they participated. Jim L was confirming that M.F.T. would be a resource for us to be a more farm friendly town. Will wants

8. Board Discussion:

Ernie drove 5 miles from the Fire Department and most of East Livermore Falls is in the 5-mile radius for the Insurance benefits.

Jim Cyr lives on Diamond Rd and said people dump mattresses over the bank because they do not want to pay the fee at the transfer station. He suggested that we get license plate numbers for people who do not want to pay the fee and leave their trash on the roadside, another suggestion was to have no littering signs on Diamond Rd in both directions, or have a camera. Jim L asked about 2023 audit, and Carrie said they are saying we will have it in May. Jim also reminded everyone of the Municipal vote on Tuesday the 23rd. Jim L would like the board to consider having Portland Trust to come and work with us on investing our money. Jim L

presented Ernie and Jim Cyr with a certificate of appreciation for their work on the board.

9. Department Head Discussion:

Abe said they had a very active month with 452 service call last month, 23 calls had likelihood to become violent or involve weapons in the last month. 26 calls were medical, and Officer Adcock saved a life with Narcan. Mutual Aid from Jay is at 61% and 39% Jay asks for our aid Even being shorthanded 25% of the Officers time they are generating their own calls.

19 were arrests

27 reports which is nearly one report a day

8 Motor vehicle accidents

16 motor stops

The PD received a \$3,000 grant for 3 computers, and they were awarded a grant for body armor, which will cover 50% of the cost over the next year.

10. Town Manager Report

Shiloh and Carrie had a zoom meeting with AVCIG about working on a recreation master plan with the three towns. They are going to write a grant to fund the master plan for us, it's a better approach using the three towns. Spruce Mt., French Falls and our Rec Park are the three areas for the grant. Some things we would like to do are redo our tennis courts, an outdoor fitness court and bathrooms. Jay is talking about accessible trails at French Falls, an amphitheater, Spruce Mt., snow making equipment and work on their parking lot. This will be a phased plan, and the grant ranges from \$50,000 to \$200,000 there is a match on this, and it can be done by in kind, so that can be done by Carrie's time, the Comprehensive plans time or the Boards time, we can also use a little bit of the TIFF money. Jay was talking about using their recreational money. Carrie did not have a chance to talk to Livermore yet and she needs signatures on the letter of support for

AVCOG for them to move forward with our grant application. Jim L asked if anyone had questions and Will said it was exciting news and something to look forward to. As requested by the board, we have suggested hours the Town Office could be open and would like to survey the residents at the Municipal vote on Tuesday. It was mentioned to do this last fall when we changed our hours to be open one night a week. Will said with doing the survey, maybe more people will realize we are open late one night a week now. After some discussion about the sign out front, the board agreed to survey the residents about new Town Office Hours.
